



The Sterling School/ Charles Townes Center is a school with a vision. Upon its inception, the vision was to bring together a community in need of resources and students who were invited based on

their 2nd grade test scores. The students in the Charles Townes Center are invited, highly gifted students from Greenville County. The school is named after Charles Townes, a Nobel Prize winning physicist who invented the "Maser", a device that when higher frequencies were applied became the "laser".

In recent years, the Sterling/CTC strings program has experienced notable growth. The students in this program have achieved Superior ratings at both SCMEA and other festivals every year for the past 4 years. Formed in 1994 by Mr. William B. McIntyre, the Blue Ridge HS Honors Concert Choir, under the direction of Laura G. Morris, has consistently received superior ratings at contests in South Carolina and in the Southeast. Regularly placing in the top three at SC State Chorus Festivals since 2000, the Concert Choir's most notable performances garnered SC State Championships won in the AA and AAA divisions respectfully in 2004, 2009, and 2014. The Honors Men's Choir (comprised of the men in Concert Choir and the ensemble that won in 2014) also placed third overall across all divisions. The Concert Choir has also recently become state champions in the state sight-singing competition as well, winning the title in March of 2015. While traveling to Orlando this year to compete in the national Disney choral festival, the Concert Choir placed first nationally in their class and placed third overall across all divisions. His choirs consistently receive superior ratings at state and national adjudicated festivals. In 2012, he conducted a city-wide youth choir for Charlotte at the Democratic National Convention while conducting his own students for events which featured national government and political officials.

Mr. Johnson has taught on all levels of schooling, is a two-time Grammy music educator, and received the Grammy Signature Schools Enterprise Award in 2011 and 2015. He was named Star Teacher for Bessemer City High School 2011- an award which recognizes the lifetime most inspiring teacher of the school's valedictorian. He was also honored in 2013 by the Community Services Association of Charlotte, as a recipient of the Community Champion Award for services in the area of music instruction, which was attended by community and political leaders, including Congressman Mel Watts and Lit. Governor Walter Dalton.

He currently serves as choral director for Lakewood High School, the Sumter Civic Chorale, minister of music for Grant Hill Baptist Church in Rembert, SC and president of the executive board for the Palmetto Voices of SC. He has been recently awarded the 2015 Professional Alumni Award for Winthrop University and has presented a session for the South Carolina Alliance of Black School Educators' state conference.

University of South Carolina Wind Ensemble Columbia, SC

Winner of the 2014 American Prize, the USC Wind Ensemble is the premier wind band at the University of South Carolina. Passionately committed to new music, the ensemble has premiered works by numerous composers, including Joseph Schwantner, Jennifer Higdon, David Dzubay, Joseph Turrin, and William Bolcom. In addition, the Wind Ensemble embraces the standard wind band repertoire, including works by Paul Hindemith, Arnold Schoenberg, Aaron Copland, Karel Husa, Vincent Persichetti, Gustav Holst, and the many other great composers who have contributed wonderful music to an ever-growing repertoire.

In recent years, the USC Wind Ensemble has performed before the College Band Directors National Association (2013), the American Bandmasters Association (2014), and the South Carolina Music Educators Association (2011). In addition, in March 2012 the ensemble toured the People's Republic of China, performing sold out concerts in Beijing, Shanghai, Hangzhou, Shaoxing, Huzhou, and Zhuji. The group's standing-room-only performance in Beijing's National Centre for the Performing Arts was broadcast live throughout China, and the ensemble also performed for the members of the People's Liberation Army of China Military Band in Beijing.

The ensemble has two critically-acclaimed CD's available worldwide: A disc on the Naxos label featuring the music of Leonard Bernstein and a disc on Mark Records featuring the group's live performance at the 2013 CBDNA National Conference. Both recordings are available at major online retailers as well as on major download sites, including iTunes. A third disc is currently in production with an anticipated release on the Summit Records label in early 2017.

Scott Weiss is the Director of Bands and Sarah Bolick Smith Distinguished Professor of Music at the University of South Carolina, a position he has held since 2010. Previously he served on the faculties of the University of Kansas, the Indiana University Jacobs School of Music, Lamar University, and Emory University. He also has nine years of public school teaching experience, including six years as Director of Bands at Harrison High School in Cobb County, Georgia, where his wind ensemble was featured at the 1999 Midwest Clinic.

Under his direction, the USC Wind Ensemble has performed before the College
Band Directors National Association (2013), the American Bandmasters Association (2014),
and the South Carolina Music Educators Association (2012). In 2012 the ensemble also
toured the People's Republic of China, performing 7 standing-room-only concerts in 6 cities, including a sold out
performance in the National Centre for the Performing Arts in Beijing that was telecast throughout the country.
Together, Weiss and the USCWE have recorded three discs on the Summit, Naxos, and Mark Custom labels; and
the group has commissioned and premiered dozens of new works by composers such as Samuel Adler, William
Bolcom, David Dzubay, Jennifer Higdon, Joseph Schwantner, and James Stephenson.

Equally at home conducting wind ensembles and symphony orchestras, Scott Weiss maintains an active international conducting schedule. Recent appearances include critically-acclaimed concerts with the Shenzhen Symphony Orchestra, the Hunan Symphony Orchestra, the Nanchang Philharmonic, the Shandong Symphony Orchestra, and the Inner Mongolia Symphony Orchestra. He has also been an artist-in-residence at leading music schools around the world, including the Central Conservatory of Music (Beijing), the Shanghai Conservatory of Music, and the University of Western Australia.

Dr. Weiss earned an undergraduate degree in trumpet performance from the Indiana University Jacobs School of Music and both a master's and a doctorate from the University of Illinois. He is the recipient of multiple teaching awards, and former conducting students of his hold major conducting and academic posts throughout the world.

The Lexington High School Jazz Band had its beginnings as a stage band club that met once per week in the early 1960's. Under the leadership of Dr. Richard McMahan (LHS band director, 1968-1979), the club became a full-fledged jazz ensemble that became a part of the school curriculum, meeting daily as a class throughout the year. Dr. McMahan, along with other influential directors from around the state, worked with the SC Department of Education to develop and adopt a jazz curriculum that allowed students to receive credit for jazz band as a class in the early 1970's.

During the 1980's, jazz band was not a part of the band program at LHS. In the spring of 1994, the jazz band was re-established as a volunteer group that met one day a week after school by Dr. Jerry Gatch. When Lexington High School moved to a block schedule, the jazz band returned to the school curriculum, meeting daily in the spring semester. Currently the LHS Jazz Band continues to meet as a class during the second semester. Students in the LHS Jazz Band pursue a curriculum that includes both full ensemble and combo performance. Class time is devoted to the study of various jazz styles and improvisation, and each student is required to improvise a solo in both rehearsal and performance settings.

Over the years, the LHS Jazz Band has worked with a number of guest artists and professional clinicians including Marvin Stamm, Roger Pemberton, Clark Terry, Tommy Ferguson, Ed Soph, John Riley, Matt Wilson, Terrell Stafford, Luis Bonilla, Scott Wendholdt, and Steve Fidyk. LHS has hosted performances and clinics by various collegiate jazz ensembles and the USAF Airmen of Note. At least one concert per year features a guest performer, often professional musicians from the area. Recent guest soloists include Dick Goodwin, Bryson Borgstedt, Lauren Meccia, John Entzi, Mary Clare Gatch and Tony Roebuck.

The Lexington High School Jazz Band has consistently received superior ratings at the SCBDA State Jazz Festival and is a regular participant in the Northwestern High School Jazz Discovery Festival. LHS student musicians have been selected frequently for the SCBDA Jazz All-State Bands, and many continue to perform at the collegiate level.

The band performs several local concerts each spring and has been a featured ensemble at the South Carolina Teacher of the Year Gala and was honored to serve as the house band for the annual Palmetto's Finest Awards Ceremony sponsored by the SC Association of School Administrators. Additional performances include full ensemble and combo performances for area schools, churches and retirement communities.
