- NAfME Hill Day, June 27-30, 2018, Washington, DC
- Evaluation tool for rehearsal-based classrooms
 - President Dickey yielded the floor to Gregory Pittman who presented resolution and motion re: evaluation of music educators
 - Seconded
 - Discussion
 - Motion did not pass
 - New Motion: We move the formation of a special committee of South Carolina Music Educators Association members to construct a document that will assist school administrators and district officials in interpreting rehearsal-based classroom procedures and techniques in terms of evaluation and observation instruments such as AdvancED's ELEOT and the South Carolina Teaching Standards 4.0 rubric, and initiatives such as the Profile of the South Carolina Graduate. The committee shall consist of individuals appointed by the SCMEA President. The committee shall research the existence of documents similar to the proposed document. As they deem necessary, the committee shall consult with Carrie Ann Power, the Standards and Learning Education Associate for Visual and Performing Arts at the South Carolina Department of Education during the construction of the proposed document. The committee chairperson, elected by the committee membership, shall report its progress either in person or by written report at each scheduled SCMEA Board meeting until the project's completion.

 - Chris Selby: New Motion: Amend Article I, Section 4. Divisions: This organization shall be composed of seven divisions: 1) Band, 2) Choral, 3) Elementary, 4)
 Higher Education, 5) Orchestra, 6) Piano and 7) Guitar.
 - Motion has been seconded.
 - Discussion:
 - approving this motion will put this to the SCMEA membership for a vote requiring 2/3 of voters voting in favor to pass.
 - Martin Dickey: What about other emerging ensembles? Should we wait?
 - Chris Selby, Michael Weavers: We shouldn't wait for others.
 Guitar has demonstrated they're ready. Let's not wait approach other groups who are not yet ready for this.
 - Jonathan Burbank: Steel Bands may be headed in this direction, but we're not yet ready or organized enough. Maybe in the next couple years.
 - Chris Selby: Who can participate?
 - LH Dickert: Any student from a school where their teacher is an SCMEA member.
 - Martin Dickert: Highly recommend you look at this question. Do you have by-laws?
 - LHD: We have a framework. Will be looking at other divisions'
