SCMEA Status Reports

President's Report – Martin Dickey

- Southern Division Meeting in Nashville, TN September
- NAfME National In-Service Conference, Dallas, TX November
- CAEP Meeting Report Lisa Rayner attended
- General Music Certification in SC: Martin yielded the floor to David Perry for a report on the Higher Education Arts Forum
 - David Perry submitted both electronically and in hard copy a document entitled "Response to the South Carolina Arts Higher Education Forum – January 25, 2019, Winthrop University."
 - David explained the new broad add-on certification in music certification by exam. No one from the music education community was consulted in the process of building the policy.
 - o Lisa Rayner noted that Dance had strong representation in the process and were able to shape the policy to insure there was a level of rigor and integrity in the dance add-on requirements. Other states have seen high pass rates on the examonly add-on certification. SCDE is not interested in hearing complaints about not being involved. The only way they will listen is if we come to the table with a solution to the teacher shortage.
 - o David noted that we should have a unified response and recommendations.
 - Discussion regarding the formation of an arts education advisory council to the policy makers
 - Upon recommendation of the Executive Board of SCMEA, Martin Dickey appointed a committee to research this issue and create recommendations for solutions to the add-on certification issues at hand: Christine Fisher (advisory), David Perry, Bradley Wingate, Lisa Rayner, Patti Foy.

Conference Chair Report – Sharon Doyle

- Each division equipment chair will receive a menu of available options as well as a list of things the division will have to provide. Will help new presidents-elect.
- Exhibitors will be looking to register for 2020 next week.
- Need conference info by August 1. Can't copy and paste into Cognito please type in.
- At-Large sessions
 - Most Band Division session proposals were inadvertently submitted as at-large sessions this year. Band Division will clarify this for 2020.
 - o Michael Moore: At-large sessions are good space for intentional emphases (e.g. improvisation). Would like to get input from Divisions at the May meeting.
- Exhibit Hall on Thursday
 - o Meetings got moved up into the Exhibit opening slot. This impacted foot traffic.
 - We must hold these at 7:30pm or later.
 - o 5pm too early? PRX couldn't get floors vacuumed in time. Some exhibitors want the 5pm time, others said 3 hours was too long.
 - Need a GRAND opening.
 - o Pre-conference earlier.
 - Other ideas: Open bar reading session, "beer choir," local craft brewers, coffee houses, cheesecake
 - Lisa Rayner: Added sessions on Thursday mean added conference expense. Need a conference committee to work on conference earlier.

Executive Director Report, Patti Foy

- 1160 registered about 100 of those didn't check in
- \$82,000+ from registrations
- Links for clinicians
- Had problems with people who thought they didn't need to register if they try to come to just one session
- Some asked for refunds (sick, change of plans). We can't do this.
- Sold 132 booths. There are 140 spaces need to reclaim these for next year. We sold a couple booths on Thursday.
- Increase exhibitor fees?
- We can get more money in sponsorships.

Past-President Report, Lisa Rayner

- Will send out a post-conference survey through app
- App engagement up this year
- 961 users, 800 logged in
- This data will be shared with exhibitors

- Exhibitors need to get a copy of the conference program
- Event staff was great this year
- Can we provide a box lunch for exhibitors? Increase fee?

- Martin Dickey: Considering new web platform for conference registration. Possible new
 website. Polled the divisions on what their website needs are, interest in a new SCMEA
 website that would serve their division.
 - Band division website is working well. Ryan Tinker has a link to NAfME membership database. API developed by Cogent Path. Website cost \$20k.
 - o Orchestra has had difficulty determining exactly who is in their division. Have a password-protected website through NAfME.
 - o Choral division we would be happy to return to SCMEA website. We need a way to verify membership too.
 - o Guitar Division concurs.
 - Martin will invite Ryan Tinker to a meeting with division webmasters, SCMEA webmaster.
 - NAfME CRM is being updated. Access to the database has been subject to a fee of \$1000 in the past.
- Patti Foy: By-laws require collegiate president to be present at executive board meetings and conference in order to get funding for National Assembly trip. Martin will have a conversation with collegiate chair.
- Need to remind executive board members that attendance at meetings is requirement to maintain good-standing membership.
