Add-on Certification Update – Patti Foy:

We are concerned that this is dependent on passing Praxis test only. The test is rigorous, but book knowledge is not enough. Patti has examined the NASM musicianship standards and the SC curriculum standards, and the report from David Perry and Higher Ed Division. Suggesting adding on a performance test to measure musicianship. Asking the State Dept. to fund a mentor. We don't see many people being successful without the degree. David Perry met with SC-Arts Alliance, JP McLeer, SCDOE – the certification

by examination is passed. SCDOE may be open to a higher ed panel for future input. We want to contribute positively as we are able.

Congratulations to Chris Selby (Charleston School of the Arts Orchestra) and the band directors at Wando Band for acceptance to Mid-west Band and Orchestra Clinic this coming year!

Financial records for tax filings – our accountant does not do an audit, just a review. We are so large and complex, it is best that each division do it its own internal audit.

NAfME Societies and Councils – seeking nominations. Chris Selby was on the orchestra council and Lisa Rayner served on the general music council. ADDENDUM - DIVISION AND CHAIR REPORTS

2019 SCBDA May Report

May 11, 2019

The SCBDA had a very successful year. Registrations and attendance at our events were up across the board. Our event chairmen continue to do an outstanding job for our association. Marching Events, Leslie Gilreath, Chairman: 121 bands (9,726 students) registered for the SCBDA State Marching Championships at 13 different sites.

Region/All-State Events, Jessica Wofford, Chairman: 8, 790 students registered to audition for SCBDA Region/All-State auditions. This is the highest number of registered students for this event we have had in the past three years. A sixth region was added to accommodate our growing numbers. Jazz Events, Mark Yost, Chairman: 199 students from 39 schools were registered for auditions this year. 127 students (64%) auditioned which is about average. There were 18 schools represented in the all-state jazz bands this year which is about average. 47 ensembles registered and 43 attended jazz festival.

Winter Ensemble Events, Dustin King, Chairman: We did not have a Winter Ensembles Championship this year. The committee is charged with re-establishing this event for the 2019-2020 school year.

Concert Events, Craig Davis, Chairman: 370 bands registered for the SCBDA Concert Performance Assessment at 8 sites across the state, serving approximately 18,000 students. 12 bands will participat in the State Concert Festival on May 11.

Solo & Ensemble Events, Matt Boiteau, Chairman- 270 schools participated with approximately 6,500 students from across our state performing at 7 sites.

SCMEA Professional Development Conference, Chaz Paxton, Chairman: Attendance at all concerts and clinics were up from the previous year. Using the USC Alumni Center for our large ensemble performances and some meetings continues to work well for all involved. We are currently accepting performance and session applications for the 2020 SCMEA Professional Development Conference. Performance and session applications are due by June 1.

President-Elect- Chuck Deen, band director at North Augusta High School, was elected in February as our President-Elect. Chaz Paxton, band director at D.W. Daniel High School, is our incoming President.

Collegiate Business Meeting

Traditionally, this meeting has been held on Saturday during the first session timeslot, so this was a new change as implemented and passed by SC NAfME at last year's Collegiate Business

Meeting. For the 2nd year, this meeting was held Thursday @ 7:30 pm, coinciding with many of the

other SCBDA business meetings, however this was not coordinated with the Intercollegiate Band

schedule, "forcing" a few participants to leave rehearsal to attend. I have had an informal discuss

with Dr. Presley, who oversees the Intercollegiate Band, and an understanding was discussed. Further discussions and planning are necessary but will not be difficult to adjust.

There were approx. 40 in attendance for the meeting with representation from USC, Claflin, Limestone, Newberry, Converse, Winthrop, and Anderson. No food was food pre-ordered for this

session.

Advocacy Day

- § The Officers had discussed the possibility of having an "advocacy day" for South Carolina sponsored by SC NAfME. This was just preliminary discussions from the officers to the body general, and feedback was provided. Winthrop chapter of NAfME offered their information based on their chapter's involvement on the campus of WU.
- § I strongly recommended that SC NAfME target two specific and annually reoccurring day or dates that we advocate. The first day/date should be in the Fall, and should be a day where the officers of SC NAfME organize as many collegiate NAfME members as possible, to go to the various elected officials offices in Columbia and advocate in the manner similar to NAfME. The second day/date should be in late March (Music in our Schools month!) to allow SC NAfME to organize a "Day of Music" at the Capital. I submit that organizing these two major events, along with the "normal" business of SC NAfME, would provide a stimulating drive for enrollment within every collegiate chapter in SC, and excite performing ensembles across the state with an opportunity to perform at a prestigious event. At minimum, it would provide SC NAfME a sense of purpose every year.
- § As a body, SC NAfME did not vote on anything regarding this topic, but it was unanimously agreed that the officers and myself will discuss this further, and present this as a topic to have the body vote upon at the SC NAfME Business Meeting at the 2020 SCMEA Conference.
